**APPROVAL:** To be preapproved for phone bidding, please contact your bank and have them to jake6635@gmail.com or fax to 888.684.5929 they MUST provide that you are one of the following; 1: A customer in Good Standing-provides you to bid amounts at your discretion, 2: They state they will Guarantee your payment for a specified amount, or 3: Provide us with a Letter of Credit.

**PAYMENT:** If I am the successful bidder of an animal, I will receive an Invoice via email from Clark Management for the full amount due which includes; Brand Inspection \$10.50, Health Certificate \$10.00, 3% phone buyers fee or 6% internet bidding fee (if available) plus the final bid price on the animals purchased. Email will provide bank wiring instructions for **payment in full to be wired to Clark Management on the Monday, May 15, 2017, immediately following the auction** and must be **wired no later than noon** your local time. Please remember that some banks only wire on the hour and hold wires to be done all at once. West Coast is a 1 hour delay so please make arrangements to be at your bank when they open! Understand your banks wiring process ahead of time.

### PHONE BIDDING:

1. The horses you choose above to bid on will be assigned to one of our employees. Please know that the employee will be near our speakers which are very loud for both them and you. The day of the sale, our employee will call you between noon and 1 p.m. MST and go over the bidding process, . ie: The bid is at \$5,000, do you want to go to \$5,500, Yes or No? This is simple, and easy to understand. Please have an idea of your maximum bid as the bidding is rapid and they won't slow down to give you time to think about this. Auction time is 2 1/2 to 3 minutes/horse. If the auction **pauses**, the horse may be sold.
2. Prior to your horse entering the sale ring, the employee will phone you by 1st choice phone number, if busy the 2nd choice number will be used. Please be available during the time your horse is expected to be in the ring, we sell an average of 20 horses per hour, 3 minutes per horse, so you can estimate the time we will be calling you.
